Officer Interview Rank Composition

Instructions: All officer programs require interview board members to meet minimum rank requirements. The following chart may be used as a reference for interview board composition requirements.

General requirements for all interviews:

- The interview must consist of three officers, all of which must be of equal or greater grade to the maximum appointment grade authorized by the program for which the applicant is applying to.
- At least one board member must be an active duty Coast Guard officer. For an IDPL commission, at least one reserve officer, when practical, should be present.
- The senior board member must be O-4 or above.
- All board members must have one year or more of Coast Guard service. This may include enlisted service.

- Board membership should be built with the applicant's background and program of interest in mind (i.e. an interview board for a DCE applicant should have, when practical, a member representing the same specialty).
- A board interviewing female or minority applicants should contain, if practical, a female or respective minority board member.
- Aviation Interview: Applicants for the DCA program are required to complete an aviation-specific interview, conducted by a board comprised of aviators.
- Lawyer Interview: Applicants for the DCL and DCL-SELRES programs are required to complete a lawyerspecific interview, conducted by a board comprised of at least one active duty attorney (i.e., CG JAG).
